9/1/2022 – 8/31/2023 Statement of Work for Drainage Districts

Seneca-Warren drainage district ditch had some maintenance cleaning take place. The work started at station 170+00 and ended at station 390+77 for a total length of 22,077 lineal feet. The work consisted of just removing accumulated sediments from the bottom of the ditch. All removed material was side cast onto adjacent cropland and spread to permit normal farming operations. This work was completed in February and March of 2023. Cost of project was \$19,658.76.

Robert Nigbor, landowner in Seneca-Warren drainage district cleaned a section of his ditch. This was to repair some erosion that occurred with maintenance cleaning. Cost of project was \$200.00.
