- 1. Update the preliminary plat map with lake and stream access information to reflect compliance with Wisconsin Statues.
- 2. The sub divider shall have the preliminary plat lands evaluated for wetlands. If the site is found to have wetlands, they shall be delineated on the updated preliminary plat.
- 3. An updated "final version" of the preliminary plat be submitted to reflect changes to the original submittal.
