Committee Discussion

County crews have completed PbM crack sealing & PbM shouldering projects; open wayside; inspecting State culverts; started mowing; paving on CTH B, H & PP; bridge maintenance, culvert maintenance; surface maintenance as needed. Anticipated activities consists of mowing ditches; chip seal CTH X and Town roads; bridge and surface maintenance as needed; and start recon on CTH Y. Crash data consisted of 13 deer, 1 other, and 5 county damage claims.

IT Department will order the software for the diagnostic equipment.

The Patrol Superindendent Truck was ordered incorrectly by Sondalle Ford. They will replace with a 2016 model as they no longer make the 2015 model. The 2016 model will be a little cheaper. The P&I Committee was also informed.

Road funding options will be discussed more at the Ad Hoc Meeting.
