## GREEN LAKE COUNTY LAND USE PLANNING AND ZONING COMMITTEE MEETING MINUTES Tuesday, November 6, 2014

## **CORRESPONDENCE**

## a. Wind energy

<u>Shute</u> – The *Brown County Citizens for Responsible Wind Energy* pursued the health and safety issue of Chapter 66 that mandates the allowance of renewable energy unless it can be proven there is a health and safety issue. They received an opinion that the wind turbines are a human health hazard. It isn't clear how this will be applied to stop a wind energy farm. This is just for your information.

Starshak suggested that Shute file this for future information.

## **b.** Approval of committee fund accounts

<u>Shute</u> – Shared an email from Angie Petruske, County Clerk's Office, stating that the County Board has to act on the different carryover funds that are designated as committed. Land Use Planning and Zoning has two carry-over accounts: 1. Vehicle Purchase, and 2. Professional Services.

Starshak asked about completing the section corner project. Shute replied that these are the only line items that are committed funds.

# Motion by Toney/Moderow, unanimously carried, to approve the committed funds accounts.

The committee members received a copy of a summary, written by Kirkman, about a WisLine seminar he attended in regard to cell towers. Starshak suggested that the committee members read the summary.

## **b.** Farmland Preservation Plan update

<u>Shute</u> – Reported on the progress of the Farmland Preservation Plan update. Some of the Towns have requested Shute's presence at the meetings where the proposed maps are being discussed.

#### c. Camping – model language

<u>Shute</u> – The committee directed Shute, at the last meeting, to get samples from other counties. Marquette and Waushara had language related to camping and it appears that even though they allow it for a temporary use, there are still some standards that they apply. If the committee decides to create language stating what would be allowed, this may need to be work-shopped to create ideas. This will be placed on a future agenda when the committee decides the time is right.

# d. Comprehensive Plan – Future presentation by Ken Jaworski, Martenson & Eisele, set date(s)

<u>Shute</u> – Mr. Jaworski would like to schedule a meeting to discuss trends that are changing with land use in Green Lake County. He would like to have an open discussion so he gets familiar with land use other than farmland. He would include a presentation and open up with the discussion to the committee members. A special meeting outside of the regular meeting may work better.

Starshak agreed that a meeting dedicated to this subject would work best. The meeting is scheduled for Tuesday, November 18<sup>th</sup>, 4:30 p.m.

Shute explained that a Public Participation Plan will need to be implemented regarding the Comprehensive Plan.
