# Wisconsin Child Sex Trafficking and Exploitation Indicator and Response Guide



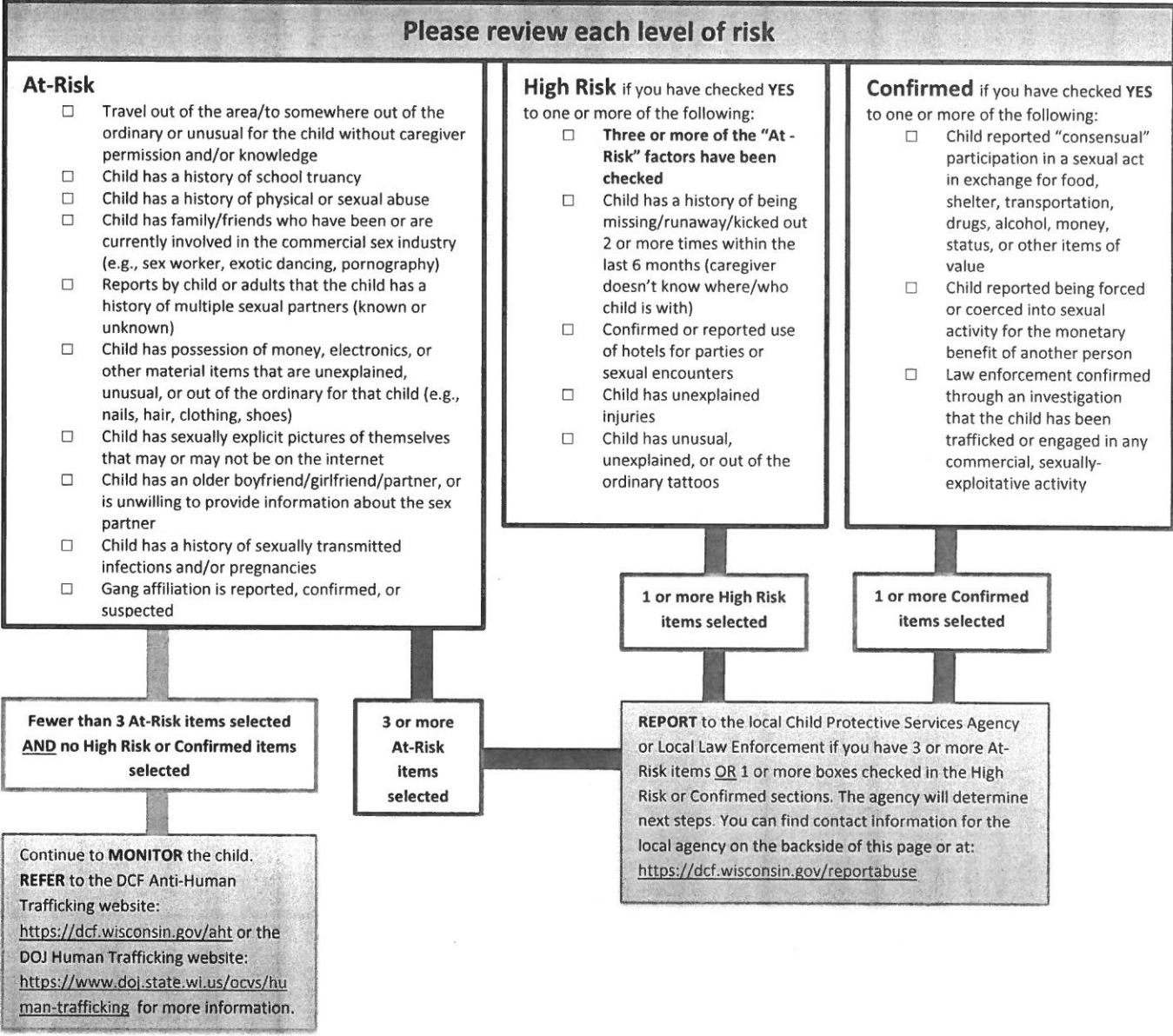
**The Wisconsin Child Sex Trafficking and Exploitation Indicator and Response Guide** should be consulted if you have concerns that a child or youth you have contact with is being sexually trafficked or exploited. Review the indicators in this guide and follow the directions for the appropriate response. This indicator and response guide also alerts the reader to indicators or potential red flags that should continue to be monitored.

**Mandated Reporters** are required to report suspected abuse or neglect of any child, including those that you may learn about through discussions with the child of concern (s.48.981(2) Wis. Stat.).

Sex trafficking and sexual exploitation are both forms of child abuse, even if the perpetrator is unrelated to the child. Although sex trafficking and sexual exploitation share similar elements, they have distinct differences, as noted below:

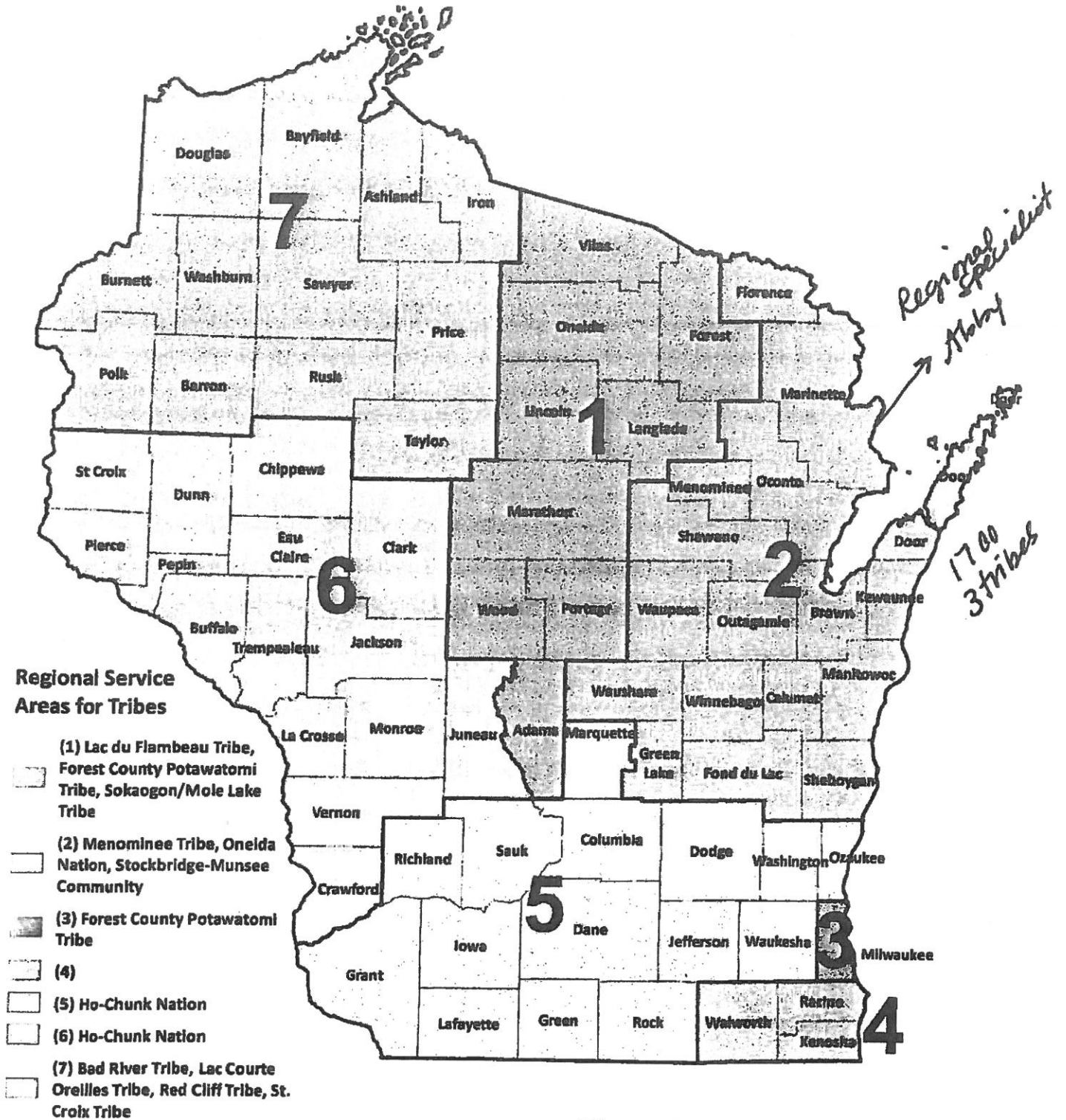
**Sex Trafficking of a Child** involves another person benefitting from forcing, defrauding, or coercing a child into a commercial sex act with another person (s.948.051 Wis. Stat.).

**Sexual Exploitation of a Child** involves forcing, defrauding, or coercing a child to engage in a sexually explicit way for the purposes of recording, displaying, and/or distributing the recording (s.948.05 Wis. Stat.).

## **What is Denim Day?**

In 1997, a 17-year-old girl in Italy was raped by her 45-year-old driving instructor during her very first driving lesson. An hour later, he abandoned her in an alley and told her that if she told anyone, he would kill her. Undeterred, she told her parents and pressed charges. As a result, her perpetrator was tried, convicted, and sentenced to jail.

Months later he appealed the sentence, taking it all the way to the Italian Supreme Court in Rome. Within days, the case against the driving instructor was dismissed, and he was released from jail. In a statement the head judge argued, “Because the victim wore very, very tight jeans, she had to help him remove them and by removing the jeans it was no longer rape but consensual sex.” Enraged by the verdict, many women in the Italian Parliament protested by wearing jeans to work as a call to action—and Denim Day was born!



## Wednesday, April 25, 2018

Why observe Denim Day? It is a symbolic gesture recalling an Italian court that overturned a rape conviction because, in their opinion, the victim's jeans were so tight the perpetrator could not have gotten them off without her assistance.



Sounds outrageous, yet in Italy and all over the world, women and men who are victims of sexual assault continue to be accused of causing an assault due to their behavior--or fashion sense. *This must stop!*

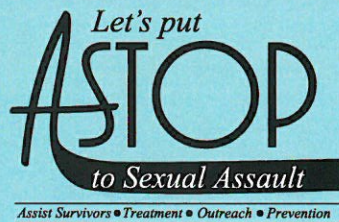

## Mission:

**ASTOP is a sexual assault service provider offering treatment, outreach, and prevention, emphasizing hope and connection with self and others.**

ASTOP provides a link between crisis and recovery. The trained professional staff offers supportive services to survivors of sexual abuse, rape, or incest as well as to their affected family members.

Serving Fond du Lac, Green Lake, and Waushara Counties, ASTOP is a 501c(3) nonprofit organization established to assist survivors with treatment, provide outreach services that create awareness of the impact of sexual abuse, and reduce the incidence through prevention education programs. ASTOP offers cost-free services to adults, teens, and youth.

**ASTOP offers emotional safety, support, and information for anyone who has experienced sexual abuse or any unwanted sexual attention.**

## ASTOP's services include:

- Absolute confidentiality
- 24-hour crisis line
- Immediate support
- Individual and family short-term counseling with qualified staff
- Referrals to other agencies as appropriate
- Education and awareness programs
- Medical and law enforcement advocacy
- Support groups

**Sexual abuse is ANY forced, coerced, or unwanted sexual activity.**

Some examples of sexual abuse include:

- You were touched without your permission in ways that were secretive and confusing.
- You were asked to touch the offender in a sexual way.
- You were watched while undressing for the gratification of the offender.
- The offender acted out sexually in some way, knowing that you could see or hear the behavior.
- The offender talked sexually inappropriately when you could hear what was being said.
- You were sexually violated by a member of your family, a close family friend, or an acquaintance.
- You were raped by a stranger or acquaintance, or you were coerced into any unwanted sexual activity.

Sexual abuse can happen to anyone at any time at any place. It can happen to people of any age, sex, race, income level, sexual orientation, marital status, or physical ability. The majority of survivors are sexually abused by someone they know.

## Sexual abuse is against the law.

Out of all the cases of sexual abuse reported, statistics show:

- One out of four females and one out of six males are sexually abused by their 18th birthday.
- In 92% of the cases, the victim knows the offender.
- Only one of ten cases of sexual abuse is ever reported.
- Sexual activity under the age of 18 is a crime punishable under Wisconsin law even with consent.

## ASTOP provides prevention education

Since 1992, ASTOP has been an advocate for survivors of sexual abuse. ASTOP is also working with the educational systems and other organizations to inform and educate our community. Our goal is to create an environment free from sexual violence.

## ASTOP trained and experienced staff provide at no charge:

- Protective Behavior programs in the schools to students from pre-kindergarten through high school
- Training and presentations for local colleges
- Informational programs for area clubs, church groups, and service organizations
- In-service for professionals in health care, government, and education

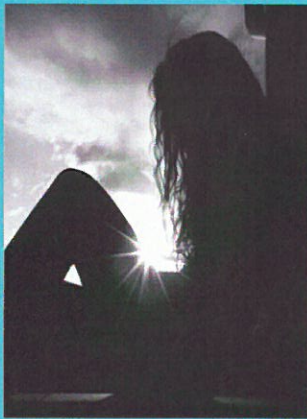
## ASTOP teaches the Protective Behaviors process

- Identify your emotions so you can tell when you feel safe, adventurous, and unsafe.
- Identify Early Warning Signs (EWS) — physical sensations that signal when not feeling safe.
- Create a network of safe people with whom to share your feelings.
- Persist in talking to those in your network until your Early Warning Signs go away.
- Solve problems by using the one-step-removed approach: "How can you feel safe even if..."



## Vicki's Story

She looked off into the distance, trying to make sense of her life. Eleven years old was too young to die; kids her age were supposed to be happy, feeling free. "What's wrong with me?" Vicki thought, as she tugged her fiery red hair.



She felt so broken inside. She lived a double life — her cheerful smile masked her innermost feelings, never showing others the pain she suffered within the "safety" of her home. She saw things and experienced things that no child should endure — things that made her believe she was bad, damaged, and unlovable.

Her innocence was taken away, leaving her overwhelmed and confused. In desperation, Vicki attempted to tell those she trusted about her abuse, but like many victims, her cries for help were ignored. Those who believed her were unable to intervene for lack of evidence until "something serious" occurred. Thus, one mild afternoon in August 1988, Vicki took her life.

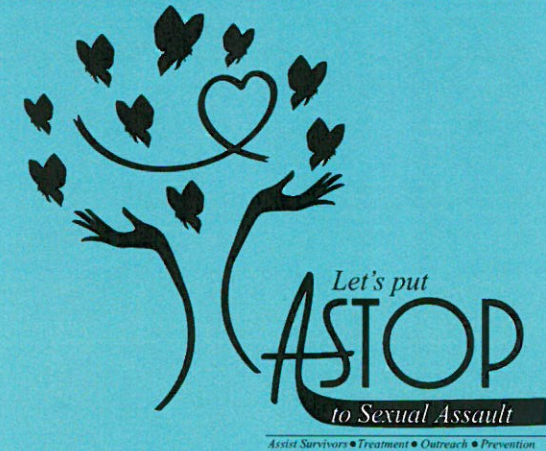
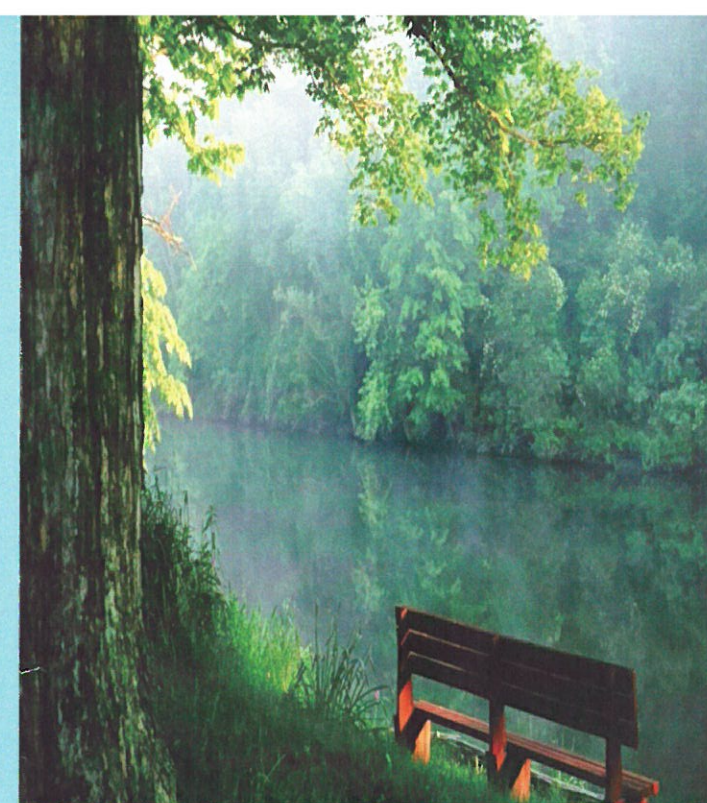
Sadly, at the time of Vicki's death, sexual abuse was underreported, highly concealed, and often lacked the necessary evidence to prosecute sexual offenders. Furthermore, it was nearly impossible to find immediate help for victims; sometimes it took six weeks to see a counselor to deal with the traumatic issues.

In response to the need, ASTOP began in 1992 as a way to assist survivors of sexual abuse. We offer legal, medical, and law enforcement advocacy, provide cost-free treatment for individuals and families, reach out to the hurting in the community, and prevent the reoccurrence of sexual abuse by educating others.

Some say hope is grief's best music. Today, ASTOP plays Vicki's song.

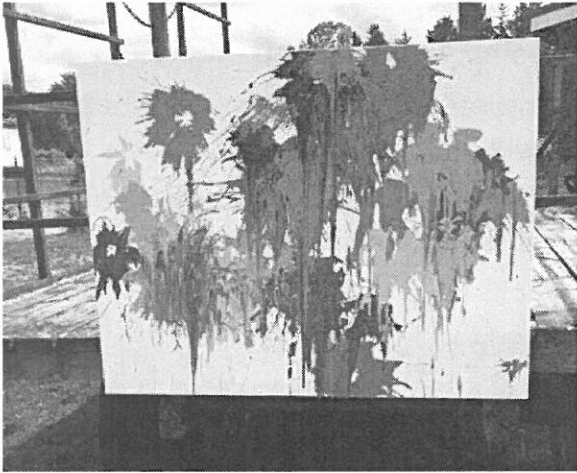

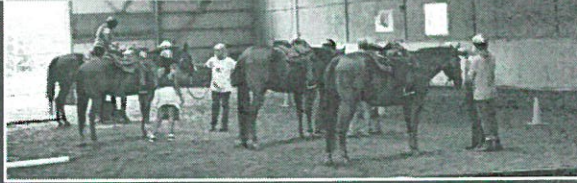

## Ropes

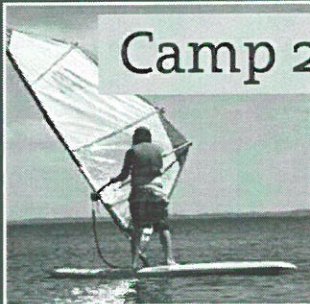
