- 7. Libraries Representatives from the Berlin, Kingston, Markesan, and Princeton public libraries spoke requesting approval for 100% funding with no changes to the 2012-2016 agreement between Green Lake County and the Winnefox Library System. A letter from Caestecker Library in Green Lake was also read.

- 8. Amy Brooks, Green Lake County Highway Commissioner, gave a presentation on the PASER rating system and the condition of the County roads. She also outlined the projects planned for 2014 on the state and county roads.
- 9. Kathy Munsey, Green Lake County Health Officer, spoke on behalf of the Health and Human Services Health Advisory Committee. She briefly explained the Green Lake County Community Health Improvement Plan (CHIP) for 2014-2018. This plan is based on the results of the Community Health Assessment.
