# **PUBLIC COMMENT**

Jay Dampier notified the Board that the ICC meeting on May 18, 2015 will focus on economic development. The meeting will be held in Green Lake County. Dampier invited members of the Board to attend the meeting.

#### **APPEARANCE**

Berlin Mayor, Richard Schramer – Regarding Economic Development: Mayor Schramer explained the development that is taking place in Berlin. Several medical offices have opened, Kwik Trip is building a new facility on the old Westside Garage site, Westside Garage has opened a new facility at the old Walmart site, Tractor Supply has opened, A new middle school is being constructed by the high school and the old middle school is being looked at to remodel into a 40 unit apartment building, the hospital is looking to replace Juliet Manor with a new building near the hospital. The Boys and Girls Club's new facility will be opened soon. Sommers thanked the Mayor for the update and congratulated Berlin on the development that is taking place.

### **GLCVB REPORT**

Linda Ruggeri told the Board that they have met with the State Department of Tourism and learned about the need to market the Green Lake area. \$34.7 million tourist dollars is spent in Green Lake County annually. GLCVB is looking into a market research company to help target the right market area. The Discover Wisconsin show will air on June 15<sup>th</sup>. They plan to go to the Milwaukee Journal Sport Show next month. She presented this year's official visitor's guide. In addition to the regular outlets for the guide, copies have also been distributed to Ripon College, State welcome sites, and Discover Wisconsin. The Heritage Tourism Guide has also been distributed.

Bostelmann stated that she is willing to represent the EDC on the GLCVB Board. Sommers thank her for volunteering.

### REPORT ON TRI-COUNTY ECONOMIC DEVELOPMENT CORPORATION

Wheeler discussed current business development and loan status. He has worked on 53 various business projects in 2014, has developed a manufacturing work group with 20 employers attending the first meeting, is working to establish a Foodie group and has updated the website design and a Facebook page is up and running. Wheeler reminded the Board that TREDC has been in existence for 10 years and he is looking at having a celebration event to mark the anniversary. He would also like to have a workshop with all three EDC Boards.
