• Consideration of Resolution to Create One Additional Position for Highway Laborer County Administrator Cathy Schmit stated that this position would be funded by additional revenues from other municipalities within the county requesting maintenance work.

Motion/second (*Guden/Jenkins*) to approve the fiscal impact of the resolution and send it to County Board for final approval. All ayes. Motion carried.

2018 BUDGET UPDATE

County Administrator Cathy Schmit explained the new format of the budget which was distributed to committee members. The budget is balanced with a 6.35% tax rate. She pointed out that several applied funds have been eliminated and incorporated into departmental budgets per the advice of the auditor. She also cited the elimination of one position in the County Clerk's office and increased revenue from the state in

several departments. No monies have been budgeted for the Contingency fund due to an acceptable current balance and health insurance deductibles have been increased. Schmit thanked the Department Heads for their great cooperation in compiling the 2018 budget. She advised the committee to review the budget and schedule a meeting to answer any questions they have with individual departments before final approval.

VIEW TAX DEED PROPERTIES

Chairman Reabe adjourned the meeting at 11:04 AM to view tax deed property at N2811 Park Road in the Town of Green Lake.

Memo to Finance Committee:

The September sales tax figure was \$156,626.71. This is another new highest amount for Green Lake County. The year to date figures show that we are ahead by \$47,609.03.

The boat launch deposits are starting to slow down for the year. Total boat launch fees collected as of September 30, 2017 is \$36,566.92. This figure is now \$10,566.92 higher than the 2017 budget amount of \$26,000.00.

TAX COLLECTION UPDATE:

There is nothing new to report on the 2016 tax collection since we issued all of the certificates in September and now it is simply a waiting came for these taxes to be paid.

I have the annual Treasurer-Clerk Fall Meeting scheduled for November 15, 2017 at 9:00a.m. in the UW-Extension Training Room. This is the meeting where we review the assessment process and current tax collection timeline with all municipal clerks and treasurers that are able to attend. We do a hybrid approach to this training since some of the Treasurer's still collect the first installment on their own. I am happy to report that we did have two new municipalities sign contracts with us this year to have our office collect the first installment for them. If any finance committee member would like to attend, you are more than welcome.

TAX DEED UPDATE:

As of today, we still have the one property in the Town of Green Lake as unpaid. Per the discussion at the Finance meeting held on October 10, action is postponed on the property until October 24, 2017 at 10:00 AM at which time the property owner must pay \$42,678.58 in full via certified funds.
