Scott Fenendael, Energy Solution Partners

2016 Fuel Contract

Scott Fenendael of Energy Solution Partners explained the basis of purchasing fuel on contract when buying futures, and answered various questions. Pence to contact Fenendael when the county budgeting process starts in order to pinpoint better budgeted dollars for the 2017 budget. Discussion held on contracted gallons.

Motion/second (Moderow/Bernhagen) to lock in the fuel price within the next 10 days and to contract 47,000 diesel gallons; and 46,000 unleaded gallons. Motion Carried.

Bike Signs and Bike Route Sign Placement Agreement

Lauree Renaud, Green Lake Greenways did not appear. Some discussion was held on costs.

Monthly Vouchers

Discussion on Cliff's Tire mounting tires versus county personnel. Schwandt would like costs looked at and brought back to the committee.

Motion/Second (Bernhagen/Moderow) to approve the December 08, 2015 vouchers for \$100,306.82. Motion Carried.

Driveway Variance, CTH X Double S Dairy

Driveway location to meet sight distance is less than 500 feet from existing driveway, therefore a variance is required.

Motion/second (Moderow/Bernhagen) to approve the Driveway Variance for Double S Dairy on CTH X in the Town of Mackford. Motion Carried.

Financial Reports

Financial Reports were reviewed and discussed, and questions answered.

Bid Opening – Purchase of Chip Spreader

One Bid Request out of four requests sent out for the Chip Spreader was received. Aring Equipment Company's bid was reviewed and delivery date of 120-150 days discussed. Price \$245,000.

Motion/second (Moderow/Bernhagen) to approve the purchase of a chip spreader in the amount of \$245,000 from Aring Equipment Company after specification review process. Motion Carried.

Sale of Equipment – Loader Unit #335

The loader (#335) should be sold because of safety issues. The minimum selling price would be \$8,928.

Discussion was held on what happens to the money when equipment is sold. Equipment depreciation process was explained regarding gain/loss on sale of equipment and the effect it has within the financial operations.

Motion/second (Moderow/Bernhagen) to approve selling the Loader Unit #335 using Wisconsin Surplus with minimum selling price of \$8,928.00. Motion Carried.

Deer Pick Up

DNR is extending contract through December 31, 2015. No costs have been determined.

Committee Discussion

Highway crews have mounted plow equipment; installing snow fence; rubber crack filling; culvert maintenance and inspections; surface maintenance as needed; winter maintenance as needed. Anticipated activities include surface maintenance; cutting trees/brush; install snow fence; and winter maintenance as needed.

Permits issued in November were 1 Driveway Permit.

November crash data consisted of 54 deer, 2 county damages, 8 other, and 0 weather.

ORDINANCE NO. _____-2016

Relating to Ordinance amending the Code of Green Lake County
Chapter 159 Highways

The County Board of Supervisors of Green Lake County, Green Lake, Wisconsin, duly assembled at its regular meeting begun on the 16th day of February, 2016, does ordain as follows:

The Code of Green Lake County is hereby amended by creating Article X, §159-29 to Chapter 159 Highways: (*Changes in italics*)

Article X – Miscellaneous Highway Regulations

§159-29 Obstructing Highways and Right-of-Ways with snow.

- A. *It shall be unlawful for any person to leave or place any snow removed from private property in piles or rows upon the traveled portion of any highway open to public travel.*
- B. *It shall be unlawful for any person to leave or place any snow removed from private property in piles or rows in the highway right-of-way of any highway open to public travel.*
- C. *All costs associated with Green Lake County removing snow that is left or placed in piles or rows in the highway right-of-way from private property, or damage to Highway equipment for removing snow that is left or placed in piles or rows in the highway right-of-way from property, will be billed to the property owner responsible.*

- D. Violation and penalty. Persons who violate provisions of this Ordinance shall be subject to a \$50.00 forfeiture for a first offense. Second and subsequent offenses shall result in the forfeiture doubling for each subsequent offense in a calendar year. (Example: 1st offense = \$50; 2nd offense = \$100; 3rd offense = \$200.) All forfeitures shall include taxable court costs and fees.*
- E. The Green Lake County Highway Commissioner or designee is hereby authorized to issue citations for violations of this Ordinance.*

Bike Route Sign Placement Agreement

This Agreement is between Green Lake County ("County"), a quasi-municipal corporation with its seat of government, and principal place of business located at 571 County Road A, Green Lake, WI 54941, and Green Lake Greenways, Inc., a registered non-profit organization in the State of Wisconsin.

Now, in consideration of the promises and covenants herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Purpose and Scope.

- a. Purpose. This Agreement is for the placement of bike route signs on County highways. The Parties recognize that bike route signage is a valuable asset to the County and improves bike safety.
- b. Scope. The area which will have bike route signs installed is the Green Lake Greenways, Inc., Huckleberry Loop, as shown on the attached map, which is incorporated by reference as if fully set forth herein as Exhibit "A".
- c. If Green Lake Greenways Inc., requests additional bike route signs installed, any additional bike route must be approved by the Green Lake County Highway Committee and must be considered desirable as shown on the *Green Lake County ~~Bicycle Priorities and Key Linkages with Current Bicycling Conditions~~ Wisconsin Bicycle* map as provided by Wisconsin Department of Transportation at <http://wisconsin.gov/Pages/travel/bike/bike-maps/county.aspx>.

2. Definitions

"Bike route" means any highway which has been duly designated by the Green Lake County Highway Committee in conjunction with Green Lake Greenways, Inc., and which is identified by appropriate signs and markings.

"Install" means to construct, manufacture, fabricate, build, raise, assemble, place, affix, attach, create, paint, draw, or in any other way bring into being or establish a sign or sign structure, but it does not include any of the foregoing activities when performed as customary maintenance of the sign or sign structure.

"Maintain" or "maintenance" means to keep in a state of repair, efficiency, or validity; to preserve from failure or decline; and to allow to exist.

3. Signs

- a. The sole authority for sign size, design, installation, maintenance, and placement belongs to the County by and through the Green Lake County Highway Department, after consultation with Green Lake Greenways. Installation, placement and maintenance shall be consistent with the Wisconsin MUTCD or other applicable state laws, administrative codes or other industry accepted standards.
- b. Installation/Maintenance
 - i. Signs will be installed and maintained by Green Lake Highway Department personnel under the direction of the Green Lake County Highway Commissioner and recorded in a sign database. All sign supplies will be stored in a location designated by the Green Lake County Highway Commissioner or designee.
 - ii. Signs may be installed on approved existing sign posts when feasible, consistent with the Wisconsin MUTCD or other applicable state laws, administrative codes or other industry accepted standards. If an existing sign post cannot accommodate a Bike Route sign, the Green Lake County Highway Commissioner shall have the sole authority to determine where the Bike Route sign post shall be installed, after consultation with Green Lake Greenways.
 - iii. This agreement is solely for the installation of Bike Route signs on County Trunk Highways. Any bike route signs for the Huckleberry Loop required on Town, City or Village roads require approval from each respective municipality. The County will not install bike route signs on Town, City or Village roads, ~~without the express written consent of the governing body of the Town, City or Village~~.
 - iv. The County reserves the right to remove Bike Route signs if they present a danger to the motoring public. If the County determines that a sign must be removed, it will inform Green Lake Greenways, Inc. at least 10 business days before removal, unless an emergency situation renders advance notice infeasible.
- c. Cost
 - i. Green Lake Greenways will be responsible for the cost of the Bike Route signs and posts. The County will mail an invoice for the cost of the signs and posts to the address in paragraph 5.c. below. Payment is due 30 days after the receipt of the invoice. Late payments will incur a 1.5% interest charge on

invoices unpaid after 40 days.

- ii. The County will be responsible for initial sign installation costs, which includes labor and incidental supplies.
- iii. If a sign or sign post is damaged due to accident, the County will attempt to recoup the cost of repair/replacement from the individual who caused the damage. If the County is unable to recoup the costs, the cost of repair /replacement shall be allocated as follows:
 1. If the damaged Bike Route sign and post is affixed to a post with a county sign, the county will be responsible for paying for the repair/installation.
 2. If the damaged Bike Route sign and post is not affixed to a post with a county sign, Green Lake Greenways, Inc., will be responsible for paying for the repair/installation.
- iv. Green Lake Greenways is responsible for all Bike Route sign maintenance costs, including but not limited to replacement signs, supplies and labor. The County will provide an invoice for the cost maintenance, payment of which is due 30 days after the receipt of the invoice. Late payments will incur a 1.5% interest charge on invoices unpaid after 40 days.

4. Liability for Accident and Injury

Notwithstanding anything to the contrary, the County expressly retains its protections under Wis. Stat. §895.825, 895.529 and 893.80, and any other liability limiting statute.

5. Miscellaneous

- a. This Agreement shall be construed according to the laws of the State of Wisconsin and venue shall lie in the Green Lake County Circuit Court.
- b. This Agreement shall remain in force until superseded or suspended at a later date. Either party may terminate this Agreement with 30 days' written notice to the other party.
- c. Notices. All notices regarding this Agreement shall be delivered by United States mail first-class postage prepaid and will be deemed delivered three (3) days after mailing. Notices may also be delivered by commercial carrier. Notices shall be delivered to the following addresses:

- d. The captions in this Agreement are for reference only and shall not be used to construe the Agreement.
- e. Each party has participated in negotiating and drafting this Agreement, so if an ambiguity or a question of intent or interpretation arises, this Agreement is to be construed as if the Parties had drafted it jointly, as opposed to being construed against a Party because it was responsible for drafting one or more provisions of this Agreement.
- f. If any term of this Agreement is to any extent illegal, otherwise invalid, or incapable of being enforced, such term shall be excluded to the extent of such invalidity or unenforceability; all other terms hereof shall remain in full force and effect; and, to the extent permitted and possible, the invalid or unenforceable term shall be deemed replaced by a term that is valid and enforceable and that comes closest to expressing the intention of such invalid or unenforceable term.
- g. The parties acknowledge that they will not hold themselves out as an agent, partner or co-venturer of the other and that this Agreement is not intended and does not create an agency, partnership, joint venture or any other type of relationship, except the contract relationship established herein.
- h. No amendment to this Agreement shall be valid and effective unless made in writing and signed by an authorized representative of each of the parties.
- i. This Agreement may not be assigned without the express written permission of the other party, which consent shall not be unreasonably withheld.
- j. This Agreement may be executed in counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute of one and the same document.

6. Effective Date

This Agreement will become effective once all parties have completed any required approval process and the appropriate representative of each party has signed below. Each individual signing this Agreement attests that they have the authority to bind their respective party to this Agreement.
