2015 BUDGETS

The 2015 budgets for the following Departments were reviewed:

Motion/Second (Wendt/Starshak) to approve the budgets as presented. All Ayes, Motion carried.

The 2015 Emergency Management Budget was reviewed. Discussion centered on the Hazmat team. With the amount of training and certifications that are required, it is no longer feasible to have our own tech level Hazmat team. We will still have a Hazmat team that can respond to the initial call, but we need a team that can respond offensively. Director Gary Podoll is recommending a model program for a two year commitment with Winnebago County's Hazmat Team for \$3,600.00 per year. The Committee agreed with the proposal; however they felt that instead of budgeting for the funds, they should be taken out of the reserves.

Motion/Second (Starshak/Wendt) to approve the Emergency Management Budget, however that the Hazmat funds should be deleted from the budget and paid for instead from the reserve fund. All Ayes. Motion carried.

The Sheriff's Office 2015 budget was reviewed and discussed. There were increases in the operating budget, the biggest changes being increases in fuel, dispatch capital equipment, and inmate medical. Decreases in revenues were also discussed. In the personnel area there is an increase in general overtime. All of the amounts were changed in order to bring the budget into a more realistic light. Supervisor Starshak commented and the Committee agreed that these increases had been discussed in the past. They are happy with the course that the Sheriff's Office has taken in apportioning the budget over the years. Though the operational budget increased, the net savings to the County at this time is \$101, 268.16.

Motion/Second (Schubert/Starshak) to approve the Sheriff's Office 2015 budget as submitted. All Ayes, Motion carried.
