Memo to Finance Committee:

The May sales tax figure was \$125,227.50. A copy of the sales tax comparison is included in the packet.

Total boat launch fees collected as of June 21, 2018 is \$13,296.92.

TAX COLLECTION UPDATE:

As of 6-21-18: We have \$6,795,308.57 left to collect, which is 16% of the total 2017 Real Estate taxes. As of 6-22-17: We had \$7,828,168.60 left to collect, which was 20% of the total 2016 Real Estate taxes.

We mailed out second installment reminders in the first part of June and since then we have seen an increase in mail as well as taxpayers coming into the office.

TAX DEED UPDATE:

This week we mailed out certified tax letters to those taxpayers that still have a balance for their 2014 taxes. We mailed out 52 certified letters. These certified letters go to all 29 owners who own on 37 parcels along with any other parties that have an interest in the property. Those taxpayers that do not sign for their letters will have their names, parcel number(s) and brief description of their property published in the newspaper as a Class 3 notice.

This year the summer WCTA Conference was at the Hyatt Regency in Green Bay. The Department of Revenue gave a very in-depth session on Lottery Credit and special charges. We gave them a bunch of questions ahead of time and they spent quite a bit of time answering those questions. This is something we have asked for repeatedly and they finally delivered. Jon Hochkammer from WCA gave an informative session on "How a Bill Becomes a Law". I really took a lot away from this session and all of the legislative terms that we toss around at conference have started to make more sense to me.

I was excited for the Economic Forecast session and it left me a slightly disappointed. I was able to take-away a few things that will help with investing of tax dollars. One prediction is that the Fed will hike rates by a quarter point in June, September and December, then pause to assess the impact. This will bring short-term rates to 2.75% by yearend. Still an improvement from where are now. Other sessions included: RFP's for banking services, a meet the treasurer session, how to maximize your leadership impact and of course, our business meeting. We had the privilege of touring Lambeau Field, which was quite impressive.

I continue to monitor any Financial Institutions where we have funds invested.
