May 2017 Projects

- 1. Begin construction of grade stabilization structure in Town of Green Lake.
- 2. Complete construction of feed leachate system in Town of Green Lake.
- 3. Complete construction of roof runoff system in Town of Mackford.
- 4. Conduct multiple FPP checks in the Green Lake watershed.
- 5. Meet landowners to discuss interest in future projects.
- 6. Begin and complete construction on a grade stabilization structure and grassed waterway in the Town of Green Lake.
- 7. Software training for Green Lake County's new Transcendent program.
