FILL VACANT POSITION

County Conservationist (Department Director):

Paul Gunderson appeared to explain the position of County Conservationist and that the Land Conservation Committee approved filling the vacancy. Discussion was held on looking at combining the Land Conservation Department with Land Use Planning and Zoning Department. This concept was looked at in 2011 by several Committees and it was determined not to consolidate the departments. The need to fill the position was discussed based on the work load and the Federal grants that are pending. Guden stated that in the past interim department heads have been paid a stipend during the time an employee acted as department head. Guden asked that the Land Conservation Committee discuss and consider a stipend for the acting department head until a new department director is hired.

Amending Ordinance 1042-2012 Green Lake County Personnel Policies and Procedures Manual: Health Insurance Appendix K HRA: Bostelmann explained that the HRA funds 50% of the health insurance deductible. This amendment would increase the amount the County funds in

The benefit plan changes approved by County board in November reduced the health insurance premium for 2014 by \$165,468. The overall health insurance premium saving with funding the HRA at 50% of deductible is \$95,958.00. *Motion/second(Wendt/Trochinski* to approve the resolution. Roll call vote, 4 ayes, 1 nay (Schwandt), motion carried.
