<u>Old Business:</u> Beuthin reported that Sue Arndt has been reappointed to the Service Commission for a three year term.

Beuthin reported that the Service Commission budget has been approved as submitted for 2011. The Service Commission budget was increased from \$3350 to \$3700.

<u>New Business:</u> Arndt reported that she would be setting up a meeting with the County Clerk, Building Security and the Veterans Service Office to plan for the upcoming Student Government Day. Beuthin reported that Lisa Liljegren will begin to send out letters to the schools in early February. Beuthin will check on the spring schedules for the schools to see if that would affect student participation.

Beuthin reported that the new County mileage rate will be \$.51 per mile effective January 1, 2011.

Beuthin reported that he had just received the WDVA CVSO Grant application and that submittal was due by May 15.

Service Office Report: Beuthin reported that for 2010 contacts were down 1.9%, mail was up 5.6% and VA hospital trips are up 6.6% as compared to 2009.

Beuthin reported that he will be working on the Annual Report which is due February 2.

Beuthin reported that he has received the WDVA Transportation Grant in the amount of \$1981.57 for 2011.

Beuthin reported that the claims for the three new presumptive diseases due to Agent Orange had started to be processed on November 1, 2010.

Beuthin reported that there were 13 veteran's deaths in the County since the last meeting, which brings the year's total to 52.

<u>Financial Report:</u> After discussion, Arndt made a motion to approve the Financial Report as submitted. Second by Soda. All ayes. Motion carried.
