#### **DEPARTMENT/COMMITTEE ACTIVITY**

#### Workshop on wind energy facility standards

The committee, staff, and representatives of Florida Power & Light (FP&L) reviewed the draft, prepared by staff, of the wind energy facility standards. The committee will consider FP&L's recommended changes and discuss this again at future meetings and workshops.

<u>Eugene Henke, Town of Mackfor</u>d – Expressed concerns about where the turbines would be placed.

### **CORRESPONDENCE**

<u>Shute</u> – Attorney Jenna Walker sent a letter expressing her appreciation for the committee's agreeing to hold a special meeting on January 15<sup>th</sup> to allow further discussion on the enforcement sections of the zoning and shoreland ordinances.

<u>Shute</u> – The Town of Manchester was granted a conditional use five years ago for a cemetery expansion. The expansion was never completed and the conditional use expires after one year.

At the time the conditional use was approved, the committee included a condition that the existing cemetery had to be recorded. The town has provided a written timeline of what has been done over the last five years. Several things have happened that are out of the control of the town and that has caused the many delays. This committee should decide if another conditional use application is necessary and whether or not the fee would be waived.

The committee agreed that the town should apply for another conditional use.

<u>Shute</u> – Corporation Counsel Selsing has asked that the committee review the correspondence regarding Keith and Carol Myers' rezoned air strip.

The committee asked that this be placed on the next business meeting agenda.
