# Review/recommendation of vacant position

<u>Shute</u> – The position that Bernie is resigning from was created in 2005 as part of the restructuring in the department. At that time, we created three code enforcement positions. I would recommend refilling the position. This committee needs to review the vacancy and make a recommendation to the Personnel Committee.

## **DEPARTMENT/COMMITTEE ACTIVITY**

Work on agricultural districts, amend.

<u>Shute</u> – I am prepared to work on amending the agricultural districts; however, based on recent county board discussions/decisions, some of the county board supervisors seem to be advocating for keeping the larger exclusive agricultural parcels. What I am recommending is to classify the smaller farmette-type areas in the residential part of the ordinance. It would still be rural in design to accommodate animals. We could amend various sections of the ag districts, especially the A-1 District because there is a lot of non-compliance with Chapter 91 Farmland Preservation. We've had the state review our ordinance and they've responded in writing as to suggestions that should be made to our A-1 zoning district. This draft incorporates their suggestions. I would also propose deleting the Ag-4 classification while leaving the rest of the agricultural districts exactly the way they are in regard to acreages.

After further discussion, the committee agreed with the suggestions/recommendations. This will be placed on the next business meeting agenda.
