Mr. Blake has marked all the holes. Before anything final happens it needs to be approved by the highway committee. Approximately \$50,000 is needed for funds. 18 holes would be accessible for everyone and 9 holes for handicapped accessible.

Mr. Selsing suggested that if trees are to be cut that the Property and Insurance committee be notified to properly notify the insurance company prior to any cutting.

Jerry Specht – Bike lanes on County Highways – he is requesting that the bike lanes be completed on CTH B and CTH H with the current construction in 2008. Roads that do not have paved shoulders are deteriorating and are a concern of bikers.

Lauree Renaud, chairman on the bike federation for the City of Green Lake – STH 23 bike path for the reconstruction of STH 23 from South Lawson to the American Baptist Assembly. 60,000 people visit the ABA annually and the residents of Green Lake will benefit. The DOT is working on the engineering plans to extend the bike path from North Street to the Green Lake Conference Center.

The riders will be bringing in tourism dollars to the community and will be a tremendous asset, approximately \$9 back for every \$1 spent.

Underpass culvert and overpass routes to route traffic across STH 23 are options for a safer route across

the STH 23.

The state will build the path, but not maintain the path. The County, the Town of Brooklyn or the City of Green Lake will need to sign off on the maintenance.

Jason Kauffeld – Fond du Lac County spends \$10,000 annually on maintaining their 100 miles of bike paths.

STH 23 Bike Path

The highway committee will be involved with the City of Green Lake and the Town of Brooklyn, but, at this time, will not sign off on the maintenance agreement.

A separate fund designated for biking would be beneficial for maintenance for all bike paths.

Motion/second (Krause/Henke) to table STH 23 bike path.

Vouchers

Vouchers were presented for \$ 122,246.09

Motion/second (Hedberg/Krause) to approve the vouchers in the amount of \$ 122,246.09. Motion carried.

Commissioner's Report

The report was sent to the Committee.

Review Crash Data and Locations

The committee reviewed the data. 2 weather related, 4 other, 6 deer crashes.

Change Valve On Fuel System

Shop 1 in Green Lake is having problems with the unleaded pump vapor-locking. The valve should be changed in Shop 1 and Shop 2 to prevent the pump locking up. It would be \$1440 for both locations and would be paid for with the \$.10 handling fee/gallon.

Motion/second (Krause/Henke) to approve the new valves installed in Shop 1 and Shop 2 for the unleaded pumps.

Bike Lanes On CTH B

Resolution 4-2008 stated that Mr. Specht told the County Board that the 2008 projects would be exempt because of the budget being set already. Highway Committee has a set budget already for the 2008 reconstruction.

Motion/second (Krause/Henke) to not construct the bike lanes on CTH B or CTH H in the 2008 reconstruction budget.

Union Posting For Grader Operator Position

A general laborer posted internally for the grader operator position. He has 15 days to pass and approve

the new position by June 25th.

Filling Of Truck Driver/Laborer Union Position

Moved for a later date after the grader operator position is finalized.
