Mascoutin Recreational Trail:

Disc Golf Grant Information: Myers has someone who will donate putting a brochure together. She also has names of individuals who will donate as soon as the paperwork is put together.

Community Foundation: Myers has talked with a student intern from HHS who is looking at developing an ADA playground. Myers will be working together with the intern for funding sources. Myers will start to work on Recreational Fund as soon as the resolution passes.

Committee Discussion:

Helmer stated that Supervisor Mueller received a call from someone who lives on Norwegian Bay and would like to have a no wake zone in the Bay to protect natural aquatic plants. He is questioning what committee would have jurisdiction for this. Discussion was held. Selsing will look into the jurisdiction question.

DRIVEWAY VARIANCE CTH FF

Podgorski explained that Ora Yoder is requesting a driveway variance on CTH FF he is requesting a variance for 350 feet. The Committee reviewed the criteria with Attorney Selsing for a variance to see if the request meets the criteria.

POSTING COUNTY ROADS

Podgorski stated that with the thaw coming roads may need to be posted for weight restrictions.

Motion/second(Galatowitsch/Krause) to authorize the Commissioner to post the roads as he sees necessary. Motion carried.

SIGN DOT ROUTINE MAINTENANCE AGREEMENT

The Commissioner presented the DOT routine maintenance agreement. The total amount is \$481,000.
