a. Review draft of the Shoreland Protection Ordinance, Articles VII through VIII The committee reviewed Articles VII through VIII of the proposed Shoreland Protection Ordinance.

b. Discuss accessory building structures height

The committee continued from the last meeting their discussion on accessory building height. Contractors Stan Arnetveit and Mike Jankowski were in attendance and were asked for their opinions. b. Resolution relating to County boundary

<u>Shute</u> – Presented a resolution that will correct the county boundary between Green Lake County and Marquette County. As part of our GIS mapping, it was discovered that the state statute legal boundary description was different than what the two counties are occupying and mapping. A new

legal description was agreed upon by the two counties and is now being presented to this committee, in the form of a resolution. If the committee agrees, the resolution will be forwarded to the County Board for their approval and then continue with the legislative process. This will result in clean boundaries between the two counties.

RESOLUTION RELATING TO THE GREEN LAKE COUNTY LAND USE PLANNING & ZONING COMMITTEE RESOLUTION OF SUPPORT

NOW, THEREFORE, BE IT RESOLVED that the County Land Use Planning & Zoning Committee supports the efforts of various county departments to prepare the information that will change the statutory description of the boundary line between Green Lake County and Marquette County to conform to the mapped boundary; and

BE IT FURTHER RESOLVED that the County Land Use Planning & Zoning Committee recommends that the Green Lake County Board of Supervisors also support this change and this resolution of support be included in any presentation of information to the state legislature or any state agency reviewing this change.
