# GREEN LAKE COUNTY HIGHWAY COMMITTEE MEETING Monday, March 12, 2007 – 9:00 A.M.

**Meeting called to order** by Chairman Helmer at 9:00 A.M.

**Certification of the open meeting law:** The open meeting law was met by publication in the official county newspaper.

**Approval of agenda:** Motion/Second (Myers/Krause) to approve the agenda with one correction. (4 Ayes, 1 Absent) Motion carried.

Mr. Galatowitsch arrived at 9:05 A.M.

Parks Business: The committee discussed the Berlin Trail. Corrections are being made to the Mascoutin Recreational Trail Conversion Plan Book. The Berlin Conservation Club (BCC) stated it is only paying 50% of the total cost associated with relocating the trail. The County is looking into the possibility of receiving more grant money. Jerry Reetz of the BCC will talk to the BCC neighbors to the East, regarding moving the easement off of the trail within the BCC grounds. Mr. Galatowitsch inquired about the requested meeting between the DNR, BCC and County, and Mrs. Myers informed the committee it was premature. Mrs. Myers is working with Chris Halbur of the DNR, and Jerry Reetz of the BCC.

Bid opening at 9:10 A.M. for concessionaire proposals:

Dan Steffens, DBA Barbie's Traveling Lunch box bid \$900.00. Phillip Mirr, DBA Bednarek's Bison bid \$1,000.01. This was held over until after appearances.

The maintenance grant for the boat ramp to place rocks at Dodge County Park has been approved and we can start preparing for them to be added. In regard to the sledding area at Zobel Park, the trees have been removed; there is a little hill that should be cut down and filled in sometime this spring. Nancy Hill questioned why Lawsonia Estates was not on the agenda. Chuck Schwartz from the Berlin Conservation Club stated that the owner of the easement is willing to work with Green Lake County on the changes that are needed. He questioned if there was the possibility that the DNR could do some of the work in order to keep the cost down. There was no further Parks business.

**Approval of minutes:** Motion/Second (Myers/Galatowitsch) to approve the minutes with additions for February 12, 2007. (5 Ayes/ 0 Absent) Motion carried.

Public Comment: None.

Appearances: Dan Steffens questioned who was awarded the concessionaire bid. Motion/Second (Helmer/Krause) to check with Corporate Council to see if we would be authorized to accept the lowest bid. This will be put on next month's agenda, with Corporation Councils recommendation. Basil Orechwa from Kunkel Engineering presented his recommendation on replacing the sewer through the fairgrounds. Motion/Second (Galatowitsch/ Myers) to put the sewer pipe along the swail or further down the north side. The Commissioner will be checking with Corporation Council on the details. (5 Ayes/ 0 Absent) Motion carried. Gene Kussart from Donahue & Associates gave the committee information on his company.

**Signing of vouchers:** Motion/Second (Biesenthal/Myers) to approve March 2007 vouchers for payment in the amount of \$95,387.14 (\$94,805.95 County, \$581.19 State, \$0.00 Others.) (5 Ayes/ 0 Absent) Motion carried.

**Correspondence:** Marge Bostelmann sent some information from East Wisconsin Counties Railroad Consortium. Governor Doyle sent a press release stating that he has recently signed a \$1.1 million contract to reconstruct Wisconsin STH 44 between Vine Street and CTH B in Green Lake County. Construction is scheduled to begin in April 2007.

**Commissioner Report:** The snowmobile club signs "In Memory of Wilbur Wick" were put on the Berlin Trail, at the clubs expense. The crews were busy plowing snow from the many recent snowstorms. There has been cracksealing done on CTH FF, B, X, & KK.

**Discuss speed limit on CTH A:** Motion/Second (Biesenthal/ Galatowitsch) to authorize Omni to do the study on CTH A from Spring Grove Road to South Street. (5 Ayes/ 0 Absent) Motion carried.

Work Zone Safety Proclamation the week of April 2 thru 6: Motion/ Second (Krause/ Myers) to present the proclamation to the county board on March 20, 2007. (5 Ayes/ 0 Absent) Motion carried.

**Wayne Banaszak driveway variance:** Wayne Banaszak & Albert Flichman presented where they would like to have the driveway entrances & exits. This was tabled until the committee can go see this property on a road tour.
