**Meeting called to order** by Supervisor Helmer at 9:00 A.M.

**Certification of the open meeting law:** The open meeting law was met by publication in the official county newspaper.

**Approval of agenda:** Motion/Second (Krause/ Myers) to approve the agenda. (3 Ayes, 2 Absent) Motion carried.

**Approve Vouchers:** Motion/Second (Krause/Helmer) to approve January 14, 2008 vouchers for payment in the amount of \$898.66. (3 Ayes/ 2 Absent) Motion carried.

**Spring Lake:** The committee looked at buoys & discussed which would be the best option.

**Zobel Park:** The hill is being used for sledding. Cindy from Ayres & Associated sent some information for the committee regarding park improvement funding for the disc golf & bathrooms.

Boat Launch fees: Collected to date, \$5,855.60.
