Discussion followed regarding engine types, retirement mileage requirements, and FRI fleet size. Schuh showed the approval letter of the last grant that was applied for. DSI's grant application was rated third among 31 grant applications submitted throughout the State. The next grant cycle will be in 2013.

Logisticare: Bradley and Schuh updated the Committee on issues with Logisticare. Beuthin updated on issues specific to Veterans. Peters wants this item on future agendas to get updates. Bender requested Care WI, Inc. on the agenda also. <u>Gas/Repair Costs</u>: Schuh updated members on gas prices and recent repairs to FRI vehicles. Schuh reported that the current rates through the Highway Department are: diesel - \$3.61 and gas - \$3.21.

Schuh reported that there was \$6,000.00 worth of repairs on 5 vehicles. Discussion followed regarding future use of LP compressed natural gas as fuel.
