Parks Business: Motion/ Second (Biesenthal /Krause) to pay the December 2006 vouchers for payment in the amount of \$258.54. (4 Ayes/ 1 Absent) Motion Jeff Hoffmann informed the committee on the status of the grant that had been submitted for Sunset Park. The Berlin Conservation Club has completed the application for land conversion and specifications for the trail barrier construction. They will be presenting it to Jeff Hoffman. Dan Steffens appeared in front of the committee and requested that the price be lowered for the next season to be a food vendor. The Committee agreed to put this on the Jeff Hoffman reported also on the grant money that would agenda next month. be possible for the bathrooms at Zobel Park. Jeff Hoffman suggested looking at the park to see if there are any other improvements that need to be done to help get this grant approved. (4 Ayes/ 1 Absent) Motion carried.

Correspondence: Howard Sell, County Board Supervisor, Marquette Village & Town Board & Marquette Volunteer Fire Department, are asking the Highway Department look at CTH H from the Village of Marquette South to the Dalton Area. They feel it is in poor condition. They would also like the Committee to also look at CTH BB & CTH B from the Village of Marquette east to 73. John Selsing Corporate Council sent a copy of the agreement between Green Lake County & Lawrence J. Brown and Raymond W. Jordinson and Hoover Shuttle, L.L.C. Ayres & Associates sent a thank you letter to the committee. Greg Stelmacher from WisDot sent a letter stating that State projects are being delayed due to financing.

Commissioner's Report: The crews have been cutting trees on County Roads. The crews have been repairing the Princeton Bridge on STH 23 for the State. The crews have been patching various County Roads. The crews worked in the Village of Kingston crack sealing and for the State crack sealing. We have cleaned up after snowstorms also.

State Bid ³/₄ **Crew Cab Truck:** The State bid was \$21,404.00. There would be a \$\$63.00 charge to deliver.

State Bid 1 ¼ Ton Crew Cab Truck: The State bid was \$33,409.00. There would be a \$63.00 charge to deliver. Motion/ Second (Galatowitisch /

Biesenthal) to recommend to P & I to purchase ¾ Crew Cab Truck from the State bid in the amount of \$21,404.00 plus \$63.00 for delivery, and purchase 1 ¼ ton Crew Cab Truck from the State bid in the amount of \$33,409 plus \$63.00 for delivery. (4 Ayes/ 1 Absent) Motion carried.

Committee Discussion: Commissioner Podgorski reported to the committee that the cost of a new 10,000 gallon diesel tank for the Manchester shop would be \$38,000.00. The cost of placing a 15,000 gallon tank in Green Lake with 10,000 gallons diesel and 5,000 gallons gasoline would be \$48,000.00.
