MINUTES

2. Minutes of December 18, 2012 were reviewed by the Board. *Motion/second (D. Richter/Guden)* to approve the minutes from December 18, 2012. Supervisor Starshak requested a change in the minutes in #38 to state "Supervisors D. Richter and Starshak are against the idea due to a number of reasons, one being cost" in regard to the purchasing of electronic devices for County Board Supervisors. All Ayes. Motion carried.

- 3. The next meeting will be on March 19, 2013.
- 4. Chairman Meyers stated that Supervisor Michael Starshak has been appointed to the Wisconsin Counties Association Ambassador Program.
- 5. Chairman Meyers stated that the Reports section of the agenda will be moved up to follow Appearances.

CHAIRMAN'S REMARKS

- 6. Chairman Meyers reminded all Supervisors employee complaints should be directed to a Supervisor or Department Head. Supervisors should not be taking on that role.
- 7. Several Supervisors have been experiencing a delay in receiving their committee packets in the mail. Since agendas and packets are sent out as late as possible to accommodate amendments and other changes, those Supervisors who are capable of receiving packets via electronic media are encouraged to contact the County Clerk's office.
- 8. Chairman Meyers stated he is willing to train any Supervisors interested in learning more about the basics of computers and electronic media. Bill Hutchison in Information Technology will set up computers in the training room for those that are interested.

- 11. Paul Gettleman of the Lake Puckaway Protection & Rehab District spoke regarding the recent activities of the group including the success rate of the portable hatchery that was implemented in 2009, shoreline restoration, nesting areas for endangered

species, and sonic tagging for walleye and carp. More information is available on lakepuckaway.com.

12. Jim Hebbe spoke on behalf of the Little Green Lake Protection & Rehab District. Recent activities include septic/holding tank inspections, Highway 44 dam inspection, lake aeration project, and land purchase to house a second weed harvester which will begin this summer.

13. Anthony Dolgner of Century21 Real Estate spoke in support of Ordinance 1045-2013 on behalf of Jon & Randall Laper. They are requesting a rezone from residential to the new R4 in hopes of selling the property.

- 14. Clerk Bostelmann read a letter from Kathy Munsey, Green Lake County Health Officer, and Judy Kasuboski, Public Health Nurse. They thanked the County Board for approving their attendance to the Quality Improvement training in Charlotte, NC in December.
- 15. Clerk Bostelmann read a letter from LeRoy Dissing, Health and Human Services Director, stating that as of January 1, 2013 the W-2 Sub-Committee is being eliminated due to the W-2 program now being administered on the state level.

Supervisor Reabe requested a correction of the date from January to February. Roll call vote on motion to adopt Resolution No. 1-2013 – Ayes – 17, Nays – 0, Absent – 2 (C. Richter, Schubert), Abstain - 0. Resolution 1-2013 passed as adopted.
- Resolution No. 2-2013 Request to State Legislature to Amend Statutory Fees Regarding Open Records Requests. *Motion/second (Starshak/D. Richter)* to adopt Resolution No. 2-2013. Supervisor Peters questioned whether this allows the County to recoup more of the costs involved. Clerk Bostelmann stated that it would. Roll call vote on motion to adopt Resolution No. 2-2013 – Ayes – 17, Nays – 0, Absent – 2 (C. Richter, Schubert), Abstain – 0. Resolution 2-2013 passed as adopted.
- Resolution No. 3-2013 Fees Regarding Recount Elections. *Motion/second* (*Schweder/Reabe*) to adopt Resolution No. 3-2013. Chairman Meyers stated that other counties are requesting this as well, including Brown County. Roll call vote on motion to adopt Resolution No. 3-2013 Ayes 17, Nays 0, Absent 2 (C. Richter, Schubert), Abstain 0. Resolution 3-2013 passed as adopted.
- Chairman Meyers requested a motion and second to suspend the rules and allow Brian Della of Public Financial Management to explain Resolution 4-2013 and Resolution 5-2013. *Motion/second (Schwandt/Thom)* to suspend the rules and allow Brian Della

to speak. All ayes. Motion carried. Della explained the savings that would be involved in refinancing the bonds due to lower interest rates at this time. Total savings would be approximately \$328,986.00 on the Justice Center State Trust Fund Loan and approximately \$64,353.00 on the Emergency Communications State Trust Fund Loan.

20. Resolution No. 4-2013 Providing for the Sale of Approximately \$7,600,000 General Obligation refunding Bonds, Series 2013A. *Motion/second (Reabe/Starshak)* to adopt Resolution No. 4-2013. Supervisor Starshak questioned the estimated rate that the bonds will come in at. Della stated they are hoping for 3.5% on the Justice Center and 1.75% on the Emergency Communication. Supervisor Peters asked what the compensation rate is for PFM (Public Financial Management). Della stated that would be approximately \$20,000.00 for the Justice Center and \$10,000.00 for the Emergency Communication. Roll Call vote on Motion to adopt Res No. 4-2013 – Ayes - 16, Nays – 1 (Peters), Absent – 2 (C. Richter, Schubert), Abstain - 0. Resolution 4-2013 passed as adopted.

Resolution No. 5-2013 Providing for the Sale of Approximately 1,435,000 General Obligation Refunding Bonds, Series 2013B. *Motion/second (Guden/Wendt)* to adopt Resolution No. 5-2013. Roll Call vote on Motion to adopt Res No. 5-2013 – Ayes - 16, Nays – 1 (Peters), Absent – 2 (C. Richter, Schubert), Abstain - 0. Resolution 5-2013 passed as adopted.
