85.21 Application for 2009 Funds/Approval - "Public Hearing": The public hearing was opened by Giesen at 9:00 a.m. Present were Transportation Committee members. Giesen explained the 2009 funding for the grant increased \$1,627.00. The increase will go to Princeton due to the usage there. Discussion followed regarding MA mileage, match funds and trust fund.
