PTD – Phil Twohig and Tom Schermerhorn of Excel Engineering. Showed design of State Correction facilities. Showed design of County facilities of Marquette, Vilas, Bayfield, Ozaukee, Fond du Lac, Presented a proposed site design on the County A property.

Potter Lawson – Beth Prochaska Paul Brummend, and Gary McLean. Showed design from Outagamie County, Douglas County, Rock County, Vernon County, Manitowoc County. Showed general design of a justice center as it relates to separation of public, judicial and secure corridors.

Venture – Tom Poweleit and Gary Jaeger. Projects are Oneida, Winnebago, Waupaca, Forest, Polk, and Washington. A site plan for the County A site was presented. A site design of the Justice Center was presented. A proposed cost of \$150 per square feet was presented.
