Vern Ammentorp – Asked why the agenda was not in the paper. How much money will be spent down town and how much has been paid to Potter Lawson and Samuels.

#### **DISCUSSION ON LONG RANGE PLAN**

Kurt Berner stated that he had some vendors that were not able to get the cost to him by this week. He is requesting a special P&I Committee meeting on August 20<sup>th</sup> and then a special County Board meeting on September 2<sup>nd</sup> and then have the plan and cost approved at the September 16<sup>th</sup> County Board. The numbers will be given as add alternatives. One is the basement under the HHS building, geothermal, parking and drives, expansion of 15 foot corridor, conference room and office suites. The committee will be given a base number and then be able to add or subtract from the base bid. Priske asked for a cost of an elevator in the HHS employee entrance.

Judge McMonigal asked why necessary parts of the courts are being considered optional. If the alternate is to change the 15 foot hallway to a 10 foot hallway it is a safety problem. Kurt explained that the P&I committee asked for a cost of the 15 foot hallway and the office suite and that is what he is providing. The Judge wants to be on record stating that the court design should not be looked at as the same type of option as geothermal.

Kurt wants to be able to give the County Board time to be able to ask questions that can be answered on September 16<sup>th</sup>.

Paul Brummund presented the plans for the building starting with the site plan, the basement below the sheriff's office, first and second floors.

Thom asked for a floor plan that can be sent out to the County Board for the August 19<sup>th</sup> meeting.
