DISCUSSION AND ACTION ON LONG RANGE PLAN

18. Supervisor Brennan stated that he was in favor of the Fabrico building only if they leveled the building and built new, but there is not enough acreage for expansion. Previously it was unanimously approved to build on the Sales property. *Motion/second (Brennan/Myers)* to recommend to Property & Insurance Committee to hire an architect for phase 1: criminal justice building, phase 2: Health & Human Services and phase 3: rest of facilities to the sales property. Spring of 2007 to be the start date. Do not start phase 2 or phase 3 until the prior phase is paid for and completed. Roll Call vote on motion – 12 Ayes, 8 Nays (Biesenthal, Dallman, Disterhaft, Gorr, Priske, Schubert, Sell), 1 Vacant. Motion passed.
