CORRESPONDENCE

DEPARTMENT COMMENTS

Mr. Traxler asked about the bids for the tower security fencing. The Sheriff responded that the copy of the purchase request form that Mr. Traxler had was amended and a new purchase request was presented to the P&I Committee as Security Fences had made an error in their bid and it came out higher than American Fencing.

The Sheriff reported that the radio switchover was completed in March and the move went well. The tactical channel has worked out well and the Sheriff appreciates all of the help and support the Committee has given to this project.

The Sheriff explained the concerns that have arisen and the plans and procedures that have been put in place regarding the STH 23 road construction project for 2011.

CTU Account

A letter was included in the packet from Captain Kevin Block of the Berlin Police Department explaining the sale of a truck that was obtained by Berlin Police Department through an asset forfeiture conviction, but has been maintained by a consortium of County Police Departments and the Sheriff's Office. It is being requested that the proceeds from this sale be placed in a carry-over account to be used for consortium CTU needs. *Motion/Second (Schubert/Zelinski)* to sell the truck as recommended and send the request that proceeds from this sale be placed in a carry-over account to be used for consortium CTU needs. DISCUSSION ON SMALL STORAGE SHED

A letter from Susan McConnell, Committee Chair of the UW Ext. & Fair Committee, regarding the small storage building was included in the packet. It is proposed that the small storage shed be turned over to the Fair Committee. However the Sheriff's Office will need fenced in external secure storage area. The Sheriff is going to get Mr. Traxler a price for the fencing that Mr. Traxler can take to the Fair Committee.

Ordinance Number 993-2011 relating to amending Chapter 187 of the Code of Green Lake County to allow the Sheriff's Office to write \$20.00 municipal citations for some of the County Parks violations. *Motion/Second (Schubert/Zelinski)* to approve the amended ordinance and send it to the April County Board meeting. All Ayes. Motion carried.

Ordinance number 992-2011 relating to amending the use of smoking and tobacco products to include outside of buildings on County property and to allow the Sheriff's Office to write \$20.00 municipal citations for those violations. This Ordinance will be presented by the Health and Human Services Board, but that Board would request approval by the Judicial and Law Enforcement Committee also as the enforcement aspect of the Ordinance is being changed. No action was taken on this Ordinance.
