## **BOAT LAUNCH TICKETS**

Luanne Kappeler-DeBraal from West Bend WI received a boat launch violation on July 3, 2011 at Sunset Park. Luanne stated that she could not find the daily permit tickets so she placed her \$5.00 in the boat launch box. She recommends that Green Lake County label the box clearly so visitors can easily find the permits.

Thom will discuss the recommendations with Scott Weir, Maintenance Supervisor to see what can be done to make the daily permit box user friendly.

## **DEPARTMENT COMMENTS**

The Sheriff stated that traffic was high over the Fourth of July Holiday weekend and had several accidents. One male drowned in Lake Puckaway when he jumped off his boat to swim and the boat drifted away from him. There were also problems in the parks with riff-raff hanging out. Sheriff stated that Law Enforcement will parole the parks more frequently. Several violations were written for littering, having glass bottles at a County Park, no parking areas and not have a boat launch permit.

Boat Parole has been out every weekend on the water and so far they have recovered a stolen boat, helped stranded boaters and gave out several underage drinking tickets.

Coroner's budget did meet the 3% reduction but needs to check on the revenue accounts for July 19<sup>th</sup> meeting.

District Attorney's department submitted the budget for 2012 before Finance made the motion to make a 3% reduction in each department. Winn Collins will bring options for the 3% reduction in the DA's Office to the July 19<sup>th</sup> meeting.

Circuit Court budget was submitted and will be discussed in further at the July 19<sup>th</sup> meeting.
