• EDC Request for County to Purchase flood damaged house

Sue Koehn from MSA explained that Green Lake County has received a grant for \$250,000 to help home owners who had flood damage. A home in rural Markesan has sustained substantial damage. The house can not be rebuilt on the existing rural lot because of an underground storage tank situation within 1000 feet. The State suggested that Green Lake County purchase the home with the grant funds and relocate the homeowner. The County could then raze the home with grant funding and could try to sell the property to a neighbor with the understanding that the lot stays forever green.

Motion/second(Helmer / Stoddard) to submit a resolution to the June County Board to proceed with the purchasing and razing of the Markesan rural lot and relocation the home owner with no County funds to be expended. Roll call vote, all ayes. Motion carried.

• Chuck Mirr, City of Green Lake Mayor discussed the City's interest in obtaining the County's well. The County felt that because of the uncertainity of the downtown location it would not be possible to make a decision whether or not to sell the well at the present time.
