Thom stated that the requirements of the open meeting law were certified as being met.

AGENDA

CORRESPONDENCE

Letter from Ruth Rodak regarding \$2,800 bill for secure detention. The division of the bill should have been between her and her Ex husband. The Tax Intercept was filed on her income, but not on her Ex husbands. The Sheriff will follow up on this and get back to the committee next month.

DEPARTMENT COMMENTS

Judge McMonigal mentioned that the committee knows what correspondence is in the packet, but the general public does not know what the committee is discussing. Dan Sondalle stated that the Correspondence should be listed on the agenda, in case someone from the public wanted to comment on it, or just listen to the discussion. Joanne Guden mentioned that she got her packet late and did not get a change to review the material. Why can't it be sent out earlier? Sue Wendt mentioned that she does not know what correspondence is on the agenda, as she does not get the packet until after the agenda and packet are mailed out. She gives Lori the agenda, financial reports and minutes and Lori mails it out. The committee would like Sue to mail the packets, as she is the Secretary and in charge of the agenda. All information should be given to Sue by Noon on the Thursday before the meeting. Anything that comes in after that will not be discussed until the following month. Dan Sondalle stated that amended agenda's are only for emergencies and should not be used to add late items. Sue will talk to Lori about this.

Mark Trochinski reported that they are using the inmates to paint the Sheriff's Department as part of an Adult Community Service program to reduce jail time.. They have done such a good job, that maintenance has requested that they paint the halls upstairs on the third floor. Inmates are also being used by the Highway Department to pickup litter along the highways.

Judge McMonigal stated that Community Service ordered by the Court is used to reduce fines and jail time. When he orders it, they have to find their own work. The probation office also has community service and now the Sheriff's Department is having Adult Community Service. The Community Service used by the Jail should be only for municipal services to reduce jail time.

Sheriff Handel mentioned that ADVOCAP has offered to pay for the donuts at the TRIAD meetings. Also the Heidle House has agreed to let us out of our contract for a boat slip as the ABA has offered us a free slip.
