## WILDLIFE DAMAGE PROGRAM - 2010 DAMAGE CLAIM APPROVALS

Steve Krueger, USDA-APHIS, presented seven 2010 damage claims. One claimant did not meet their harvest objective but based on hunter log and final harvest documentation it was recommended that the claimant be granted an exemption to meeting the harvest objective.
