Discussion held on obtaining additional revenues and rolling layoffs. *Motion (Whirry/McConnell)* to remove the part-time staff line item and to increase the Land Conservation Revenue line item to meet the levy reduction directive. If offsetting revenues are not received then rolling layoffs would need to occur in the last quarter of the year. 5 ayes, 1 abstain (Traxler). Motion carried.
