All cost estimates for chosen projects need to be given to Amy by October 1: highway shed#2 and school PV, Solar Hot Water for school and jail and maintenance garage, Wind Turbine at the Justice Center – Scott and the School are responsible. Jason was asked to check about ordinances for NEV use on city/town/county roads. Amy will talk to Mark O'Connell and Scott regarding sizing of biodiesel storage tanks. Marge mentioned possibility of \$20,000 a year of capital improvement money be put towards implementation.

Renewables: Need Health and Human Services fleet data, plus Amy needs list of car info: make, model, year, approximate roll-over dates, what will replace them (diesel, hybrid, flex fuel).

Amy will check about being able to prepay for a booth at the fair (\$125 per year) up through 2525 using grant money.
