Little Green Lake: Continued work on acquiring an additional 2.5 acres for the upper dam.

Green Lake: Discussions held on the proposed Lindenwood Development.

Puckaway: no update

Other - Twin Lakes: no update

Clean Sweep Program Update: The Clean Sweep will be held August 8-9, 2008. Collection of

pharmaceuticals is a possibility. A \$22,000 grant from DATCP has been secured.

2009 Plat Book: Sample plat books from several publishers were reviewed. The committee agreed that the extra maps such as lake depth, cemetery, school district, and roads, would make the book useful to more people. Hebbe will proceed with the plat book that includes the additional information with a projected release for Nov 2008 - May 2009.

Gypsy Moth Spray Program Update: Hebbe updated that since last month's public hearing, one spray block (#9) was cancelled due to objections and the boundaries of four spray blocks (#7, 15, 17, & 21) were altered due to objections. Invoices were sent out to landowners who have not yet submitted payments. After the March 15 payment deadline, spray blocks will be evaluated for financial support and the final determination will be made of whether or not any other spray blocks will be cancelled.

Summer Intern LTE Hiring Approval: Secured a \$2,000 grant from WLWCA toward a summer intern to work with the education and awareness of aquatic invasive species among lake residents and lake users.

Weigh Scale Purchase Approval: Awaiting price quotes for two weigh pads to help farmers calibrate their manure spreaders as part of their nutrient management plans.

Vehicle Purchase Approval: Discussion held on a replacement vehicle for the current 2001 GMC Sonoma. After researching three different pickup models, Hebbe decided that the GMC Canyon best meets the needs of the department. *Motion (Ammentorp/Williams)* to approve the purchase of a GMC Canyon per state bid specification for \$21,047. Motion carried. The 2001 GMC Sonoma will be sold at the county vehicle auction.

DATCP/County Cost-Share Contract Approvals: none

Conservation Plan Approvals: *Motion (Williams/Ammentorp)* to approve an Animal Waste Management permit for MAM Farms LLC. Motion carried.
