Other – Twin Lakes: Cost of the chemical treatment project was under budget. May purchase water monitoring equipment with remaining grant funds.

2009 Budget: A zero increase budget with staff costs was reviewed. *Motion (McConnell/Schweder)* to approve the 2009 budget as presented and discussed with a 0% increase from the tax levy (including salaries) and to forward it on to the Finance Committee. Motion carried.

Establish Timeline for Revision to Green Lake County Code Chapter 284 - Construction Site and Stormwater Management: Hebbe presented a timeline for revision of Chapter 284 with a January 1, 2009 effective date.

Farmland Preservation Program - Application Approvals: *Motion (Williams/McConnell)* to approve two Farmland Preservation Program applications for: Donald J & Lorraine Bogucke Living Trust - 39.77 ac, Town of Princeton; and Bogucke Family Trust - 191 ac, Town of Princeton. Motion carried.
