2012 CARROVER REQUEST/SUMMER INTERN – DISCUSSION/APPROVAL

Ghimire reported our office is again requesting to have our Summer Intern and has had confirmation from Morgan Fox, our 2012 intern, and she would like to return in 2013. We would like to increase her wage from \$11 to \$12/hr. (400 hrs. = \$4,800). *Motion/second (Toney/Reabe).* Approved to send it on to Finance & Personnel Committees.

COMMITTEE DISCUSSION - REPORT OF LAST MONTH'S MEETING - INCLUDING Q&A

- a. <u>Property & Insurance Committee</u> Stoddard reported the county truck sold for \$30,000.
- b. <u>Personnel Committee</u> Schweder reported they discussed collective bargaining related to union negotiations. They approved filling the Court Records Clerk in the Clerk of Courts Office and the Account Budget Coordinator in the County Clerk's Office. They also approved reinstatement of paid breaks for employees and reviewed an exit interview.
- c. <u>Finance Committee</u> Reabe reported the property on Hwy. C, Princeton, has sold for \$15,000 which covers back taxes. There is some interest with the property in Berlin. Zills asked if there was any change in policies regarding carryover funds. Reabe replied with no. The county is looking at refinancing the bonds at a better rate.
