HOUSING GRANT APPROVAL

Sue Meier appeared to explain a request for a housing project. Total loan is \$24,100. *Motion/second(Neubauer/Sommers)* to approve the housing loan. Motion carried.

<u>DISCUSSION ON POSSIBLY OPENING A THRIFT SHOP IN THE OLD HHS</u> BUILDING

Dissing and Ed Schuh appeared to provide information on their research and planning to develop a thrift store in the old HHS building. Discussion was held, questions were asked and answered. Estimated remodeling would be about \$60,000 to \$100,000. Dissing will contact Bill Wheeler to discuss possible help for the project.

ZONING ISSUES AND BUSINESSES

Field stated that he believes that the County Zoning Department has been responsive to businesses. Reabe stated that zoning has issued several permits to businesses one specifically to Gelhar Mining. Field mentioned that many of the "hot buttons" have been addressed and things appear to be going well.

REPORT ON TRI-COUNTY ECONOMIC DEVELOPMENT CORPORATION

Wheeler sent an email stating the following information on Green Lake County business.

- 1. Hunt's Repair outside of Manchester to assist with an expansion that will enable them to service semi cabs inside vs. outside for \$60,000. Increased business should bring with a couple of jobs and retain those that could be laid off in the winter months. Markesan State Bank was the partner.
- 2. Fox Valley Dental located in Berlin and Montello. Alex White, the son of Kelly White dentist in Princeton purchased the buildings and practice which has been pretty much in a caretaker state since the owner passed away several years ago. Nice project especially with one of our own coming back home. Farmers and Merchants were the primary lender. We did \$50,000 in working capital.
