FILLING VACANT POSITIONS

Information and Assistance Specialist LTE – HHS

Dissing explained that this will be a fully funded position to work for Green Lake and funding may not be available next year. This will be better as a limited term employee since it is unknown if funding will continue.

Motion/Second(Schweder/Zelenski) to fill the LTE position at this time until the resolution for a 1 year LTE is approved by the County Board. Motion carried.

Deputy Director - HHS

Dissing explained that the HHS Board has reviewed this position and that there is a need for approval. Guden appointing Bostelmann to work with Dissing on screening applications and preliminary interviews.

Motion/Second(Schweder/Zelenski) to approve the posting and advertising of the position. Motion carried.

CLERK'S REPORT

Bostelmann reminded the Committee that back in September of last year she recommended that in 2012 the Committee consider having a wage scale study completed for union employees by an HR consultant. Bostelmann stated that Brenda Keller, who did work for the County as a consultant may be willing to work on this special project. Bostelmann will investigate costs from Keller and other consultants and report back next month. Bostelmann also stated that the Committee will need to start looking at revising the Personnel Policies since the union contract will be ending at the end of 2012. Sondalle requested that no discussion take place at this meeting and that County Personnel Policies be on all future agendas for discussion.

COMMITTEE DISCUSSION

Don Peters stated that he attended a WCA seminar regarding Highway Operations and talk with the Jackson and Clark County shared Highway Commissioner. He talked with the Marquette County Highway Commissioner at a meeting this week and Marquette County is open to discussing the concept of a joint highway commissioner. Peters will continue to research this with Highway Committee Chair Gene Henke. Sondalle stated that there should be no discussion by the Committee on this subject until it is properly noticed on the agenda next month.
