FLOOD STAGE SLOW NO WAKE ORDINANCE

Chairman Thom has talked to Walleyes for Tomorrow and will be seeing representatives from the Berlin Boat Club and the Bugle Mouth Bass Club to discuss the situation with them. The Committee would like Corporation Counsel to check with the DNR. Michael Russell and Dorene Raabe were present. There was also correspondence in the packet from them. They would like to see an ordinance enacted. Chairman Thom indicated that the Committee's intent was only to consider enacting an ordinance if the river reached flood stage which is 13' in the City of Berlin. This matter is to be placed on next month's agenda.

A short discussion was held on the NSA Ruling. Supervisor Starshak stated that this ruling impacts anyone who uses the Internet. We need to be aware of it and sensitive to it.

The Sheriff reported on his National Sheriff's Training in Charlotte, North Carolina. He learned a lot and brought back many ideas he plans to implement. He expressed his appreciation to the Committee for their support.

The Sheriff stated that there have been a lot of patrols in the parks to make our presence known. We also had a big interdiction campaign last week-end.

Chief Deputy Putzke reported that we are actively working with the Markesan Police Department on an armed robbery that took place at their pharmacy recently. The prescription drug activity in the County continues to be a major concern that we are continuing to combat. He stated that the new State Budget Bill allows for golf carts on the roadway. He has already met with the Town of Princeton regarding this and plans to meet with more of the Town Boards. His hope is that if an ordinance is passed, it will be consistent in all of the Towns.

Judge Slate discussed getting a new Court Room chair. The one he has was not made for someone of his stature. The cost will be between \$400 and \$800. The Committee gave its approval for him to purchase one, after extensive testing.

Chairman Thom thanked all of the Department Heads that gave presentations at the last County Board meeting. They all did very well.

Chief Deputy Putzke reported that he had the first one half of the Lexipol Policy and Procedures done. It consists of well over 100 pages. In order for the Committee to review it, it was decided that one paper copy would be made and could be passed from one Committee member to another.
