FLOOD STAGE SLOW NO WAKE ORDINANCE

Chief Deputy Putzke reported on the follow-up meeting he had with Land Conservation regarding complaints he has received from residents on the Fox River regarding slow no wake when the river is over flood stage. Jim Hebbe was present. *Motion/Second (Schubert/Wendt)* to allow Mr. Hebbe to speak. All Ayes. Motion carried. Mr. Hebbe was very supportive of a No Wake Ordinance on the Fox River in the County during flood stage provided it is properly signed and noticed. He recommends adding educational information with the sign and to educate people via the media. Mr. Thom offered to contact the various clubs in the Berlin area such as Walleyes for Tomorrow and the Berlin Boat club that may have an interest in this proposed Ordinance, for their input. This topic should be placed on next month's meeting agenda.

PERSONNEL POLICY ITEMS FOR DISCUSSION

The Committee reported that Personnel Policy items regarding evaluations, voluntary unpaid leave requests, job interviews and exit interviews were discussed at the May County Board. It is up to the individual Committees as to whether or not they will be included at regular monthly Committee meetings. The Judicial and Law Enforcement Committee would like them to continue as they have in the past with unpaid leave requests being in open session and job interviews and evaluations in closed session. They would also like to see the written exit interview forms that employees who are leaving their employment with us fill out.

DEPARTMENT COMMENTS

Judge Slate stated that he went to recent training and found out that Mediation Fees must be spent on Mediation and cannot go back to the general fund. He also stated that \$20.00 of each marriage license fee should be going into the Mediation Fund. He also reported that Nancy Hinz, Family Court Mediator has resigned. DHS has someone within their Department that will be providing those services. He told the Committee that the microphones for the video visitation system have issues. He is working with vendors for repairs.

Tami Eisenga reported that reimbursement for Guardian Ad Litem fees is up by 74%. The Committee appreciates all of the hard work she has done on collecting those fees. Judge Slate stated that he believes the Clerk of Circuit Court Guardian Ad Litem fees will most likely be over by the end of the year.

Sheriff Podoll reported that since the last meeting there was a SWAT call for shots fired. Everything worked out fine. It was reported that there was a drug interdiction sweep last week. No drugs were found, however 41 tickets were issued along with 10 warnings, and a couple of arrests for warrants. This is funded through the State Click it or Ticket program. A State-wide Ice Storm table top was held on the 29th of May via the web. In our County it involved County Health employees, Hospital staff and Law Enforcement. No parking signs have been posted on CTH B, things are going well. A parking lot is also being created there. Hiring of a new Corrections Sergeant is still underway and Liz Pflum will be continuing on as an LTE Corrections Sergeant until a replacement is selected and trained. Boat Patrol is ready and will be out on the County waters again this season. There has been an increase in car -vsdeer accidents. Recently a motorcyclist hit a deer. The cyclist was not wearing a helmet. He was flighted out. A daytime home burglary was solved recently by Detective Chad Holdorf through the use of the Leads on Line program that the Committee authorizes to fund. The Sheriff expressed his appreciation of their support for giving us the tools we need to perform our duties.

It was also reported that in the future, the State Public Defender will be mandated to represent parents in CHIPS cases.

The Judicial/Law Enforcement Department Heads are on the agenda for County Board reports for the May County Board Meeting. The Sheriff, Chief Deputy, Judge and DA will speak at the meeting.
