Motion (Reabe/Schweder) to approve and file the September 13, 2012 meeting minutes as presented. Motion carried.

WILDLIFE DAMAGE PROGRAM - 2012 CROP PRICE PROPOSAL, 2013 BUDGET

Steve Krueger, USDA-APHIS Wildlife Services, presented proposed crop prices that will be paid for 2012 damage claims. These prices are averages of the crop prices throughout the year. The crop prices for field corn, soybeans, and wheat were adjusted to bring them more in line with current prices. *Motion (Reabe/Dahlke)* to approve the crop prices as proposed with an adjustment to the per bushel price for field corn (\$7/bushel), soybeans (\$14.25/bushel), and wheat (\$7/bushel). Motion carried.

Krueger presented the 2013 Wildlife Damage Program preliminary budget. *Motion (Reabe/Schweder)* to approve the 2013 preliminary budget as presented. Motion carried.
