**Ditch #5 - Wal-Mart Water Drainage Issue:**

**Seneca-Warren Drainage Ditch – Waushara County Ditch Cleanout:**

The Board understands the requests of landowners to clean out portions of the ditch in Waushara County. The highest priority at the moment remains the ditch area below South Road

**Seneca-Warren Drainage Ditch – Main Ditch Cleanout:**

Todd Morris spoke and explained about what the borings could do to explain the ditch original depth. Information that has been sent to DNR and DATCP will be given to Luther Olsen and the Board will ask for his assistance.
