She explained that the summary does not reflect the amount of involvement Wheeler has with the Berlin RLF and businesses development. Baranowski highlighted the TREDC report under Future Needs: "Try and coordinate efforts between our school systems and employers working alongside with the Tech Colleges to try and deliver trained employees to our businesses". He explained how important the cooperation between the State government, tech colleges and business really is to successful economic development.
