UPDATE FROM GREEN LAKE GREENWAYS ON REORGANIZATION AND TRAIL PROJECT

Ken Bates and Howard Hanson spoke on behalf of Green Lake Greenways. Easements have been registered for the trail which will be located from the Hwy 49/23 intersection to County Road PP in Green Lake County. The project will be put out to bid in March of 2019 with the intention to break ground in spring/summer of 2019. Funding will come from grants, donations, and stewardship funds. No fees will be charged for the use of the trail with ongoing maintenance funding coming from donations and other sources.

• Demonstration of Automated Boat Launch Terminals – Michael Wilson, IPS Group

Michael Wilson of IPS Group gave a demonstration of the proposed automated boat launch terminal. He answered questions and explained the fees involved with the system.

DISCUSSION AND POSSIBLE ACTION OF AUTOMATED BOAT LAUNCH TERMINALS

BOAT WASHING STATIONS AT DODGE MEMORIAL AND SUNSET PARK

Anna Cisar of Golden Sands RC& D and Stephanie Prellwitz of the Green Lake Association spoke regarding proposed boat washing stations at both Dodge Memorial and Sunset Park. Discussion held on the requirements needed to install the stations and the cost involved. A more detailed proposal and discussion will be held at the May 2019 meeting of the Parks Commission.
