Chief Deputy, Matt Vande Kolk reported the Highway Safety Traffic Committee does not recommend amending Chapter 257 Vehicles, ATV/UTV at this time due to the ordinance being in effect for only one full season; not enough time for any factual data.

Willie Conklin, Jr., explained to committee members he would like us to be consistent with surrounding counties by amending Chapter 257 Vehicles, ATV/UTV at this time to 5:00 am-midnight, year round.

Amending Chapter 257 Vehicles, All-Terrain/Utility Terrain be operated on an approved ATV route 5:00 am to midnight, year round from January 1st through December 31st
