**LAND USE REGULATIONS**

**The Green Lake County Zoning Ordinance** shall apply in the Towns of Berlin, Brooklyn, Green Lake, Mackford, Manchester, Marquette and the **Shoreland Protection Ordinance** shall apply in **ALL THE TOWNS** in Green Lake County. A land use permit is required for construction and development activities in these areas and is valid for 1 year from the date of issuance.

**“Shorelands” are defined as being:** Those lands lying within 1,000 feet of the ordinary high water mark of a lake, pond or flowage; and those lands lying within 300 feet of the Ordinary high water mark of a river or stream or to the landward side of the floodplain or whichever distance is greater.”
