RE: Department Update

Dear Committee Members:

A 6-person jury trial (OWI first offense) was held on December 12th, which ended in a guilty verdict. Expenses related to this trial were \$984.79. There were nine jury trials held in 2019 for an expense of approximately \$9,800.00. Of theses trials, seven proceeded to verdict (four guilty and two not guilty) and three settled the morning of the trial, after the jury was assembled. There is currently a 12-person jury trial scheduled on January 16th for a felony charge of Operate a Motor Vehicle Without Owner's Consent.

- December 31, 2019, 10:35 am: There was a two vehicle accident that occurred on STH 23 near CTH T with one individual air lifted out. All parties involved should make a full recovery.
