Brief Narrative of 2012 Land Information Activities (include relevant web-links):

Green Lake County's land records modernization continues to move forward. The funds from County retained fees has allowed in-house work by the GIS Specialist to continue digital parcel mapping. The latest progress check has this project at 90% complete.

The WLIP grant funds were used in 2012 to re-establish Public Land Survey System (PLSS) corners that have been unidentified for many decades. Having these PLSS Corner identified allowed for accurate digital parcel mapping to occur in those areas.

Website development and maintenance is an on-going process and some strategic funds have been used to offset the cost of an employee to perform those activities.

Education and training grant funds continue to be used for a variety of opportunities that benefit Green Lake County's effort to modernize the land records and make them available to public and private entities.
